## **Brief document on Master franchisee setup at GSRTC**

### **1. Radiant Scope:**

- Master franchisee for GSRTC and fully responsible for setting up of franchisee counters at various locations, their operation and for account of all transactions.
- Development of software for Franchisee transaction, transaction processing, tracking of sales at counters, cash management and reporting.
- Required reports in this aspect will be provided as per the requirement.

### **2. Franchisee Scope:**

- Selected candidates who agree to terms and conditions of contract will sign an agreement with Radiant.
- The period of agreement or contract will be six months for initial appointment as TEMPORARY franchisee and will be extended for subsequent appointment as REGULAR franchisee
- Franchisee will set up counter as per specifications appended in the agreement.
- The selected Franchisee shall have his own computer, printer and internet connectivity with adequate speed, bandwidth and hardware/software compatibility to conduct transactions, uninterruptedly in the specified working hours.
- Proper power back up (UPS) should be provided for uninterrupted issue of tickets.

### **3. Eligibility Criteria for selection:**

1. Applicants should be Indian Nationals above 18 years of age. Proof of age and address should be provided along with suitable proof of identity.
2. Should have minimum knowledge of Computer operations. Matriculation passed will be preferred.
3. Should not be public servant or dismissed from Government service and should not have any criminal record.
4. Should have zeal and enthusiasm to develop business.

#### 4. Refundable Deposits & Commissions.

- A processing fees of Rs.1000/- will be collected
- A refundable deposit will be collected by Radiant considering the expected sale of tickets at that area. **The refundable deposit is Rs.10,000 for individual franchisees and Rs. 50000 for network franchisees.**
- This deposit is refundable at the end of the contract with the franchisee and does not fetch any interest.
- **The franchisee gets a commission of 2.5% of the ticket sales he has made.**

#### 5. Transaction and payment mechanism

1. The business runs on a prepaid model system.
2. The franchisees will have to deposit anticipated three days transaction value of tickets in advance into Radiant cash management system to be able to use the software for booking tickets. The software will not permit transaction if the deposit falls below a predetermined level in deposit.
3. The Franchisee will have to replenish the deposit amount as and when the same reaches lowest permissible level. The details of cash replenishment centers/ banks will be informed by Radiant.
4. The commission earned on tickets will be calculated at the end of the month and will **added to the transaction deposit for the next day's transactions**, after deducting Income tax (TDS) and any other tax to be implemented.
5. They will be providing all sorts of passenger ticketing services like enquiry, issuing tickets, cancellations, issuing way bills, reservation forms etc..

#### 7. Publicity:

1. Unique design boards for the counters have to be put up by the franchisee and wide Publicity be taken up for sale of tickets.
2. Radiant also will take up wide publicity in this regard.
3. Home delivery of tickets may also be taken up.
