

Gujarat State Road Transport Corporation is formed under the Road Transport Corporation Act,1950. Gujarat State Road Transport Corporation has formed separate GSRTC Contributory Provident Fund.

The Annual investment amount is Rs 90-110 cr.(Approx). The funds of all the Trust are invested as per pattern of Investment prescribed by the Ministry Of Labour/Finance, Govt. of India from time to time. The Board of Trustees have formed the "Investment Panel" of Merchant Bankers for the Investment of Trust.

The Terms & Conditions prescribed for the Empanelment of Merchant Bankers on Panel list of Board of Trustee, GSRTC Contributory Provident Fund are as under.

## (1). The new applicants should fulfill following criteria :

(2). The Trust's fee for Empanelment is Rs.10,000/ (Non-refundable).

- (3). If there is no response on three successive occasions of furnishing quotations for Investment Proposals, the name of such 'Merchant Banker' may be considered for de-empanelled.
- (4) If it is found by the Trust at later stage that any action by the 'Merchant Banker' is detrimental to the Trust, name of the concerned 'Merchant Banker' will be permanently deempanelled from the panel list of the Trust.
- (5) However, the Merchant Banker will require Re-Empanelment fee of Rs.10,000/- The decision of re-empanelment will lie with the Board of Trustees.
- (6). Govt. Guideline instruction for Investment shall be strictly followed by the Empanelment Merchant Banker.
